

REASONS WHY AUSTRALIA MUST EXIT THE WHO

There are over 1.3 million Australians united against the power grab proposal by the WHO, and they are demanding that the Australian Government exit the unelected, tyrannical WHO and take back control of our own health decisions in our own country. Currently the WHO has an advisory role, and they want to have an International Public Health Authority role, which will have serious implications for Member States' sovereignty. The WHO is putting forward two proposals as follows; the IHR (International Health Regulations) Amendments and the Pandemic Treaty for adoption at the WHA (World Health Assembly) commencing 27th May, 2024.

1. The Director General of the WHO, Dr Tedros Ghebreyesus, is not a medical doctor, was nominated by the CCP (Chinese Communist Party) and is a terrorist and who was a member of the TPLF (Tigray People's Liberation Front) and is accused of genocide in his home country of Ethiopia.
2. The WHO receives substantial funding from corporations with serious conflicts of interest, such as the Bill & Melinda Gates Foundation, GAVI and Big Pharma Companies.
3. The WHO's proposal that Australia's health decision making process be relinquished to the WHO under what is to be known as ONE HEALTH, is extremely concerning and a loss of our unalienable human rights.
4. The changes to the IHR will see mRNA 'vaccines' produced in less than 100 days with indemnity provided to the pharmaceutical company, mandated 'vaccinations', medical procedures, vaccine passports, travel restrictions and isolation for non-compliance. (Remember all those quarantine facilities built across the country in 2022?)
5. The ramifications of the WHO being able to make decisions on *potential or perceived* pandemics is of considerable concern. Eg: July 2022 Tedros declared the Monkey Pox outbreak a Public Health Emergency of International Concern, overriding the expertise of the WHO Emergency Committee. The document is very loosely worded and could also pertain to *perceived environmental issues* for which we could be forced into lockdowns. Covid was just a trial to see how far they could push us, and easy-going Australia was the test case.
6. The WHO will be able to issue legally binding directives to Member States and their citizens that will force all to follow, such as censorship of information, with the WHO deciding what is misinformation and disinformation.
7. The WHO is currently in violation of the existing IHR as they continue with negotiations, while failing to provide the document in its entirety with the fully proposed changes. Only leaked portions of the document have been provided to the public.
8. The WHO has declared that they will control and oversee G.O.F (Gain of Function) Gain of Function research, which was more than likely behind Covid-19. Surely this research should be banned before we see even deadlier planned pandemics.
9. Considering the catastrophic harms the WHO's policies caused during the Covid-19 'pandemic', which has been shown to be far greater than the virus itself, the potential economic and health related harms of such power cannot be overstated.
