My name isand will be voting in the upcoming council elections. Please forgive the intrusion, but I recently heard the news about the Port Hedland local council ruling on DNA contamination in the mrna Covid vaccinations, and I believe all local councillors will be hearing about this soon. So I wanted to ask your thoughts on this.

If you are not familiar with this, just recently in Western Australia the Port Hedland Local Council has passed a motion to suspend all mrna covid vaccinations due to DNA contamination found at levels over 145 times the TGA acceptable limit. I have watched the videos of the council meeting, if you have not seen this yourself I encourage you to watch it. It's very informative and at a level which is accessible to everybody.

Quoting from the conclusions of the above link :- The Special Meeting on October 11, 2024, was a landmark moment for Port Hedland and, potentially, for Australia. The council's decision to take a stand on DNA contamination in mrna injections reflects not only the concerns of its community but a broader national unease about injection safety. With five out of eight council members reporting adverse events after vaccination, the decision to act was not just a matter of policy but of personal conviction. As the council moves forward with its plan to alert local governments and health practitioners across the country, the ramifications of their decision could be felt far beyond Port Hedland. The question now is whether other councils will follow their lead—and whether Canberra will finally break its silence on this critical issue. The action taken by the Port Hedland Council is a wake-up call for communities across Australia. Now, more than ever, it's crucial for people to stay informed and act. Share this information widely, alert your local councillors, and demand that they address the serious concerns raised about DNA contamination in mrna injections. By speaking up,

we can ensure that this issue receives the attention it deserves and push for transparency and accountability in our health system. Don't wait for others—this is the time to take action for the safety of our communities.

Given the local council elections coming up, it seemed very timely to send this to you as one of our local nominees. This topic has some close relationship to my own family as we know two people recently diagnosed with cancer, making me wonder whether the mrna vaccinations could be a factor.
